### To be eligible for a subdivision lot discount, the recorded plat must contain at least 10 building lots.

Application must be filed with the County Assessor by May first of the year for which the discount is eligible to be claimed. Failure to timely file will result in the lots being assessed at market value. However, if the developer misses the May 1st filing deadline, a late application for the discount may be filed until the 30th day following the mailing of the property tax bill and must include a \$100.00 late application penalty payable to the Pickens County Treasurer.

If a lot allowed the discount is sold to a licensed-residential homebuilder or general contractor, the licensee shall receive the discount for one additional year if the purchaser files a written application within 60 days of the date of sale.
